Class 1: Regional Council of Government Associate Membership

Membership includes one copy each of *Southern City*, *League Letter*, *Legislative Bulletin*, NCLM Annual Conference mailings, all general mailings and all reports. Membership also includes eligibility for participation in any of the three Risk Management Services insurance pools. Membership does not include voting privileges.

Annual dues for this class of membership: \$157

Class 2: Limited Service Associate Membership

Membership includes one copy each of *Southern City*, *League Letter*, *Legislative Bulletin* and NCLM Annual Conference mailings. Membership also includes eligibility for participation in any of the three Risk Management Services insurance pools, provided that the entity is eligible under applicable statutes and agreements. Membership does not include the legal inquiry service or voting privileges.

Annual dues for this class of membership: \$406

Class 3: Full-Service Associate Membership for Small Associates

Small affiliates are defined as having all of the following, so far as applicable: budget of less than \$1 million annually, fewer than 25 employees, less than 1,000 water or sewer meters in services, or treatment of less than 17 million gallons of water or wastewater per day. Membership includes one copy each of *Southern City*, *League Letter*, *Legislative Bulletin* and NCLM Annual Conference mailings. Membership also includes eligibility for participation in any of the three Risk Management Services insurance pools, provided that the entity is eligible under applicable statutes and agreements, and access to all other League services, with limited access to the legal inquiry service. Membership does not include voting privileges.

Annual dues for this class of membership: \$1,568

Membership does not include voting privileges.
